AEW ANNOUNCES OFFICE ACQUISITION IN CENTRAL HONG KONG FOR \$129 MILLION

BOSTON, November 30, 2016 – AEW Capital Management ("AEW") announced today the acquisition of Continental Place in Hong Kong for \$129 million. Located in the Central district of Hong Kong, Continental Place represents the ninth investment that AEW has acquired on behalf of AEW Value Investors Asia II, the second in AEW's series of value-added funds focused on property investments in Asia's gateway cities.



Continental Place is a newly constructed 29-story office building totaling approximately 50,000 square feet, which includes a 4-

story retail podium. Its prime location along Des Voeux Road provides superb public transport connectivity. The property sits on top of the Sheung Wan MTR subway station, one stop from Central station in the heart of the Central business district. "The Hong Kong Central office market is very tight, with vacancy in the 2%-3% range" said David Schaefer, Managing Director and Head of AEW Asia Limited. "It is rare for such high-quality office assets to become available in Hong Kong, and we are pleased to be able to add this very well-located asset to our portfolio."

The property maintains strong visibility with considerable street frontage and also enjoys views of Victoria Harbor from the sixth floor up. AEW has contracted JLL to assist with the property's office leasing efforts as the property is leased to stabilized occupancy, and the retail leasing efforts will be led by AEW's asset management team.
